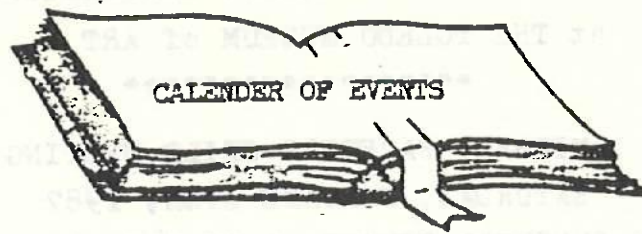

1988 CHALLENGE CONDITIONS 1988

- ### Challenge conditions, continued

12. Packing of the stones for shipment, whether domestic or international, may be specified by the committee setting the competition schedule.
13. Entries are limited to only one per competitor. Each entry is deemed to cover four stones; one in each section named in the schedule.
14. A completed entry form constitutes the acceptance of this schedule and any regulations it specifies, and is an agreement to comply with them.
15. No member (or the spouse) of the competition committee from any country, shall be eligible to compete in this competition.
16. Entry forms, and any fees required, must be received by the competition committee by the date specified as part of these conditions, and directed to the address of the committee indicated thereon. (For 1988 there will be no entry fee.)
17. All entries of stones shall be received by the competition committee by the closing date set by the committee. Failure to do so will render the entry ineligible.

SECTION ONE

FAIRY WAND

By Edith Strout

Hartfield, Calif.

FAIRY WAND is one of two designs contributed to our Volume 3 Book of Gem Cuts. Like the brilliant cross it is a challenge for the experienced cutter. Again the brilliance is outstanding. We have made trial cuts on large Rhodolite Garnet (12 mm. finished size) and light Peridot (11 mm. finished size). Each was a truly beautiful "GEM" and gave great satisfaction. Care must be taken so that all three sections of the star facets should be equal in width at the table. It is also necessary to have all three segments of the girdle facets equal in width at the girdle line.

CUT AND POLISH TABLE IN 45 DEGS. ANGLE DOF OVER 60% OF THE WIDTH OF THE STONE.
CUT GIRDLE AND SHAPE STONE ROUND BEFORE STARTING ANGLE FACETS. CUT AT 90 DEGS.

CROWN CUTTING ORDER:

- 1st. EIGHT FACETS AT 42 DEGS.
INDEX--64-8-16-24-32, etc.
- 2nd. EIGHT FACETS AT 35 DEGS.
INDEX--64-8-16-24-32, etc.
- 3rd. SIXTEEN FACETS AT 28 DEGS.
INDEX--2-6-10-14-18, etc.
- 4th. EIGHT FACETS AT 26 DEGS.
INDEX--4-12-20-28-36, etc.
- 5th. SIXTEEN FACETS AT 50 DEGS.
INDEX--2-6-10-14-18, etc.
- 6th. EIGHT FACETS AT 53 DEGS.
INDEX--4-12-20-28-36, etc.

POLISH ORDER--USE DIAGRAM AT LEFT (CODE)
USE SAME ANGLES-ADJUST TO FIT.

NOTE: As with the crown, the three segments of the girdle facets should be equal width and align with the corresponding ones on the crown.

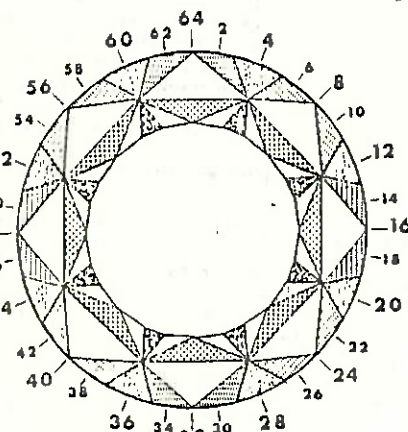
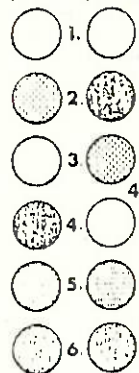

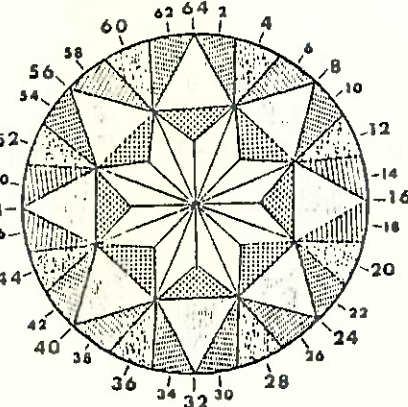
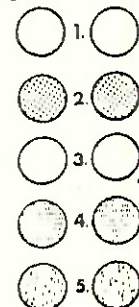


SIDE VIEW

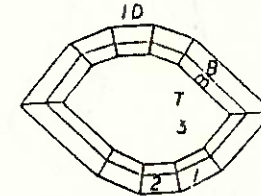
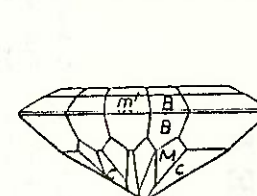
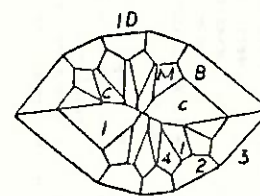


SECTION TWO

SYMBOLIC EYE CUT

49 facets

Proportions 1.6 to 1

PAVILION: no true symmetry, 96 index, using some asterisk settings, and setting to either side.

1- ten culet facets (c) at culet angle, on settings 9, 57/84, 36/90, 42/96, 48/6, 54. These are variable in size, but must meet along the S-shaped culet keel.

2- ten break facets (B) at culet angle plus 10°, on step 1 settings. These will touch the girdle area and cut the step 1 facets to blunt points.

3- ten girdle facets at 90°, on step 1 settings. These will determine the size and proportions of the stone.

4- eight main facets (M) at culet angle plus 2°, on settings 87, 39/93, 45/3, 51/71, 551. The 71 and 551 settings may be accomplished by either cheating to midpoint between 7 and 8 and 55 and 56; or placing the index pointer on the tip of the tooth between these settings.

POLISH: 1-4-2, and the 1D setting facet on the girdle. (96)

It must be noted and understood that when the stone is redopped, it is completely reversed and only the central facets that were cut on 1D setting and its opposite and the asterisk settings to either side are the only ones that will be in alignment with the crown settings.

CROWN: using some pavilion settings, and settings to either side. Align the stone by indexing the polished 1D setting facet to 1D setting. Place an unpolished girdle facet flat to the polishing lap. Polish the girdle on settings 39, 42, 48, 54, 60, 86, 90, 96, 6, 12.

1- ten break facets (B) at crown angle, on the settings used to polish the girdle.

2- cut and polish the table (T) at 0°, to where its width is 60% of the width of the stone.

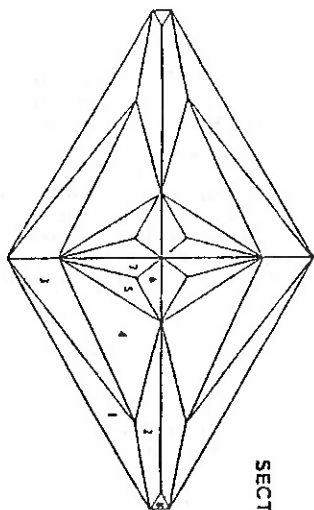
3- ten main facets (m) at crown angle less 6°, on step 1 settings.

POLISH: 3-2-1.

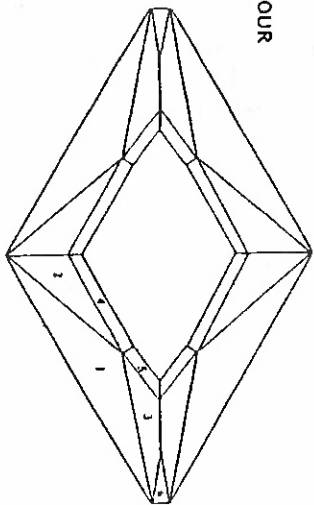
This is a difficult diagram to cut. A great amount of care is necessary when cutting in the pavilion main facets in order to have them make the three central breaks be the same depth. Two of these main facets must be split half way between two index notches.

In order to attain the correct girdle proportions, the pavilion step 3 facets must be carefully cut.

Cutting the crown is no problem.



SECTION FOUR



KANGAROO CULET

53 facets 96 Index

PAVILION CA = Culet Angle

Preform stone at 90°, on index settings used in step one. Truncate points at 24 & 72 at 90° just enough to place the small end facets.

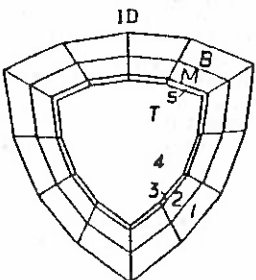
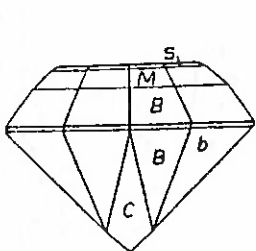
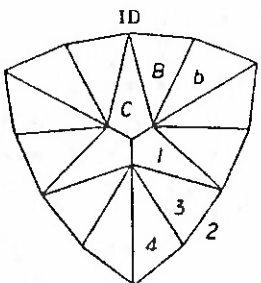

The points of this diamond shape are truncated and the four small facets offer no optical assistance, but they do contribute to what I call chip insurance. Without them, the sharp ends are vulnerable. The angle of these facets on the crown are not important, just please your eye.

When cut, this stone seems to have three culets. The center, or true culet, is flanked by two pseudo culets which revolve and "jump" back and forth as the stone is turned.

SECTION THREE

TRILLIANT B
52 facets

Contributed by Basil Watermeyer

PAVILION: three-fold symmetry, 96 index, using alternate asterisk settings and settings to either side.

- 1- three culet facets (C) at culet angle, on ID and alternate asterisk settings. (96,32,64)
- 2- twelve girdle facets at 90°, on the second and sixth settings either side of step 1 settings. (94,2/30,34/62,66/6,26/38,58/70,90) These should divide each side into four equal portions.
- 3- six break facets (B) at culet angle plus 2°, on the second setting either side of step 1 settings. (94,2/30,34/62,66)
- 4- six break facets (b) at culet angle, on the sixth setting either side of step 1 settings. (90,6/26,38/58,70) These end at a point about three-fourths of the way from girdle to culet, leaving a large culet area. Change the angle if necessary.

POLISH: 1-3-4. Do not polish the girdle.

The pavilion of this cut was shown in Watermeyer's Diamond Cutting. It was evidently assumed that the crown of one of the the other cuts would could be used. The liberty of using a step crown was taken. The step crown is excellent with the barion cuts, thus it was assumed that it would work nicely here.

CROWN: using pavilion settings. Align stone by indexing the central point on any side to ID setting. Place a girdle facet flat to the polishing lap. Polish the girdle on pavilion step 2 settings.

- 1- twelve break facets (B) at crown angle plus 15°, on the settings used to polish the girdle.
- 2- twelve main facets (M) at crown angle, on step 1 settings.
- 3- twelve star facets (s) at crown angle less 15°, on step 1 settings.
- 4- cut and polish the table (T) at 0°, to where it reduces the star facets to the desired size.

POLISH: 4-3-2-1.

Trilliant B produces a very brilliant gem. It is especially good with high RI materials.

THE STANDARD ROUND BRILLIANT

The most important of the brilliant-cut styles is the Standard Round with 57 to 58 facets. In this style, the inclined facets are triangular or more or less kite shaped.

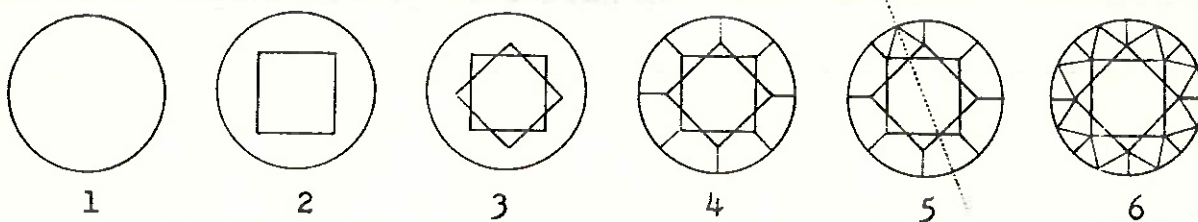
The crown(that portion of the stone above the girdle),consists of 33 facets: 1 table, 8 star facets, 8 main or bezel(the inclined area of the crown between the girdle and the culet)facets,and 16 break or upper girle(the portion that encircles the stone) facets.

The pavilion(the inclined area between the girdle and the culet), containing 24 or 25 facets: 1 culet(the small flat facet at the point where the pavilion mains meet), 8 main or pavilion facets,and 16 break or lower girdle facets. The culet is sometimes omitted, especially in colored stones. The purpose of the culet is to reduce the possibility of damage.

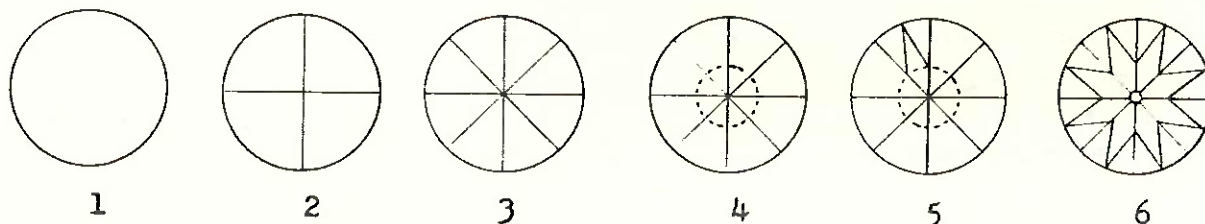
DRAWING THE STANDARD BRILLIANT

THE CROWN

(1) Draw a circle, (2) place a square in the circle, (3) place another square at 45° angle to the first,(4) draw lines from the points of the square, (5)with a dotted line bisect the points formed by the two adjoining star facets, (6) connect the points of the star facets with the midpoint of the dotted line.

THE PAVILION

(1) Draw a circle, (2) draw two lines at 90° to each other,(3) place another set of 90° lines at a 45° angle to the first,(4)draw a smaller circle inside the the first circle,(5)draw lines from the intersection of the small circle and cross lines to the midpoints of the arc of the larger circle, (6) draw the rest of the pavilion facets as in step 5.

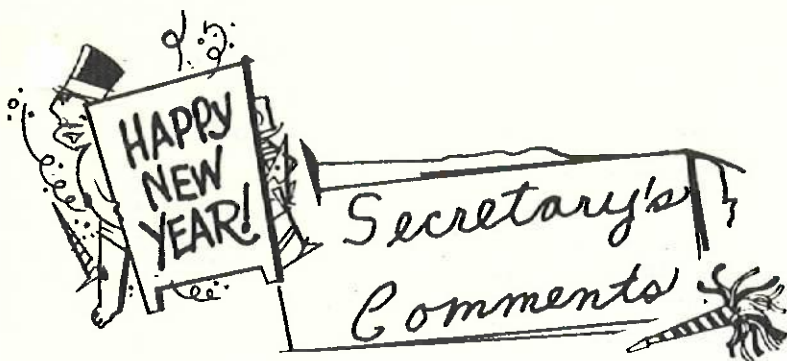

The Board Meeting of the Midwest Faceters Guild was called to order by President, Bill Horton at 9:28 A.M. on October 25, 1986 in the Mt. Clemens Recreation Center, Mt. Clemens, Michigan. Those attending were: President Horton, Ted Engel, Bernard Bush, Elery Holt, Dorothy Loyd, Joe Manina, Harold Rice, Kathleen Myers, Bill Schell, Royal Olson, Rosa Manina and Frances Bush.

The minutes of the August 9th meeting were approved as published in the October, "Midwest Faceter", through a motion made by Ted Engel and seconded by Elery Holt.

A copy of the Treasurer's report submitted by Elery Holt was accepted and filed for audit through a motion made by Dorothy Loyd and seconded by Bernard Bush.

OLD BUSINESS:

Dealers contracts for the Show have been mailed out and a deposit on the Dearborn Civic Center has been made. Contracts were sent to 12 prospective dealers and 6 manufacturers.

Programs being considered are Arthur Grant, a faceter at Smithsonian, with a possible 400+ carat fluorite as a special exhibit. His program would be on Soft Stones and Big Stones. From G. I. A., John Koivula, Eunice Myles, Don Goodger and Thomas Ricks will be invited to present talks and programs.

A letter was received from Chairman Kleepe of the Southern California Federation agreeing to no showing of the Competition Stones for the Australian-American challenge until after the judging. Date and place of competition still to be decided upon.

It was agreed the Chairman of our Special Competition, Ed Myers, would be the logical and best representative of the Midwest Faceters Guild to go to California to head up the judging through a motion made by Harold Rice and seconded by Bernard Bush. The motion will be presented to the Membership for approval. One judge will be selected from each Guild and will use a 10 power, hand held loop for judging.

The Faceters Guild has been invited to set up the Special Competition Contest in Oklahoma City for the American Federation Convention. Kathleen Myers may be unable to attend and would need some one that is going to set up the case and take care of the awards and bring it back home.

NEW BUSINESS:

Dan Clark requested that the Guild assist with the symposium at Breckum Dam, Texas and give programs.

The Program Chairwoman, Dorothy Loyd announced the January 17, 1987 meeting will be at the Toledo Museum of Art. Reservations must be made one week prior to the meeting so please contact Dorothy as soon as possible. If reservations are made you must pay if you attend or not, as this is a special event to see the Walters Art Gallery "objects of Adornment: Five Thousand Years of Jewelry" including works from Ancient, near Eastern, Egyptian, Etruscan, Greek, Roman, Byzantine, Migration, and Medieval periods as well as pieces from the Renaissance through the early Twentieth Century. The tour includes 213 pieces of the finest jewelry and will be shown in ten chosen cities. The Toledo Exhibit will be from December 14, 1986 until February 8, 1987. Other meeting dates are March 14th (needs a Host), May 23rd, London; August 15, Field Museum or Cleveland Museum of Natural History; and the Annual Meeting October 3rd at Mt. Clemens, Michigan.

Dorothy needs a letter to verify the guild will furnish proper lighting to exhibit a 39.5 carat Alexandrite from the Smithsonian. The 20 watt - 12 volt quartz light bulbs are \$3.50 per bulb and needs ceramic socket transformers. Cost would be approximately \$15 to light the case. Bob

Springer will be asked to make the case as it must be on a pedestal and requires back lighting.

Bill Schell suggested that a 1.6 carat of Red Beryl from Utah, valued at \$10,000 may be had for a Special Exhibit, also.

A Special Bulletin for the Special Competition will be mailed soon.

The CZ for the World's Famous Gems for the Field Museum will be cut with the quartz angles. CZ has a critical angle of 24 so that should be taken into consideration, also.

Dorothy announced there was a CZ Gemstone display at the Michigan Inn, Detroit until 5 P.M. today.

President Horton announced the resignation of Florence Hill and the appointment of Harold Rice as the Michigan State Director of the Midwest Federation.

Meeting adjourned through a motion made by Bill Schell and seconded by Joe Manina.

The Midwest Faceters Guild was called to order by President, Bill Horton on October 25, 1986 in the Mt. Clemens Recreation Center, Mt. Clemens, Michigan.

The minutes were accepted as published and the Treasurer's report was accepted and filed for audit as read by Elery Holt.

COMMITTEE REPORTS:

Dorothy Loyd, Program Chairwoman, apologized for the cancellation of the program that was to have been presented by Don Sahr on Gem setting. Don became ill and was unable to attend. Today is the election of Officers. The next meeting will be at the Toledo Museum of Art to view the Walters Collection of Fine Gems. Dinner will be approximately \$5.50 plus tax and tips. Meetings and Lunch will be held in the Terrace Room of the Art Museum. Reservations must be made in advance. The March 14th meeting is in need of a volunteer Host Club. The remainder of the meetings for 1987 are: May 23rd, hosted by the London, Ontario Club; August 15th will either be the Field Museum or the Cleveland Museum of Natural History and October 3rd the Annual meeting at Mt. Clemens Recreation Center, Mt. Clemens, Michigan.

The 1987 Show Committee reported the Dealer Contracts have been sent out. They have three suggested speakers and tentatively some special displays.

For the Special Competition a new rule has been adapted. The winners must sit out two Shows, but may enter a different class with different stones.

The Midwest Faceters Guild will work with the judging for the Australian Challenge. Judges will be from the Texas Guild, California, Rocky Mountain and Midwest Guilds. More details as they become available for September judging.

Historian, Vivian Randall has slides of members taken by Dr. Rugenstein that will be made into prints and placed in the History Book. Vivian will have the History book on display at the Show.

We are desperately in need of a new Editor as Helen Taylor and her husband are retiring and moving to Maine. Articles are also needed.

President Horton stated that Mr. Foltz of Duran, Michigan is looking for special faceters. If interested in doing some commercial work, please see Bill for details.

The Flint Club invited two members to be guests at their Annual Banquet on November 1st. Joan Connor and Dorothy Loyd agreed to accept the honors.

We received a request to help with the Symposium to be held May 22nd and 23rd in Breckum Dam, Texas. No one will be able to attend so our regrets will be sent by President Horton.

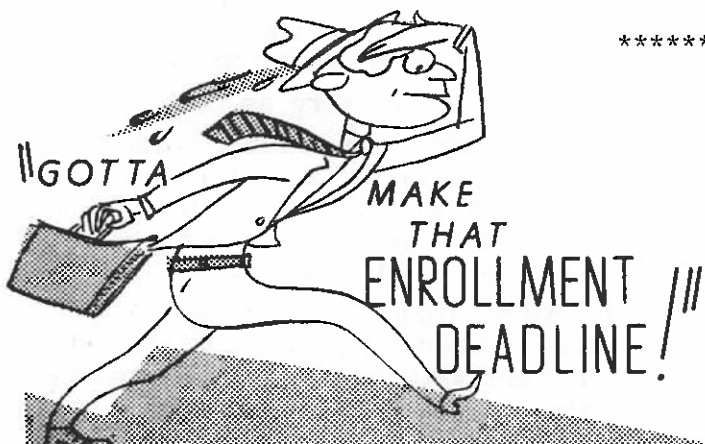

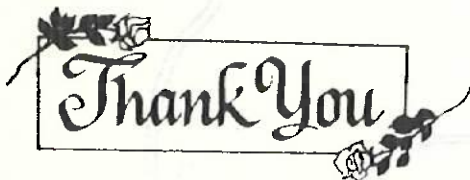

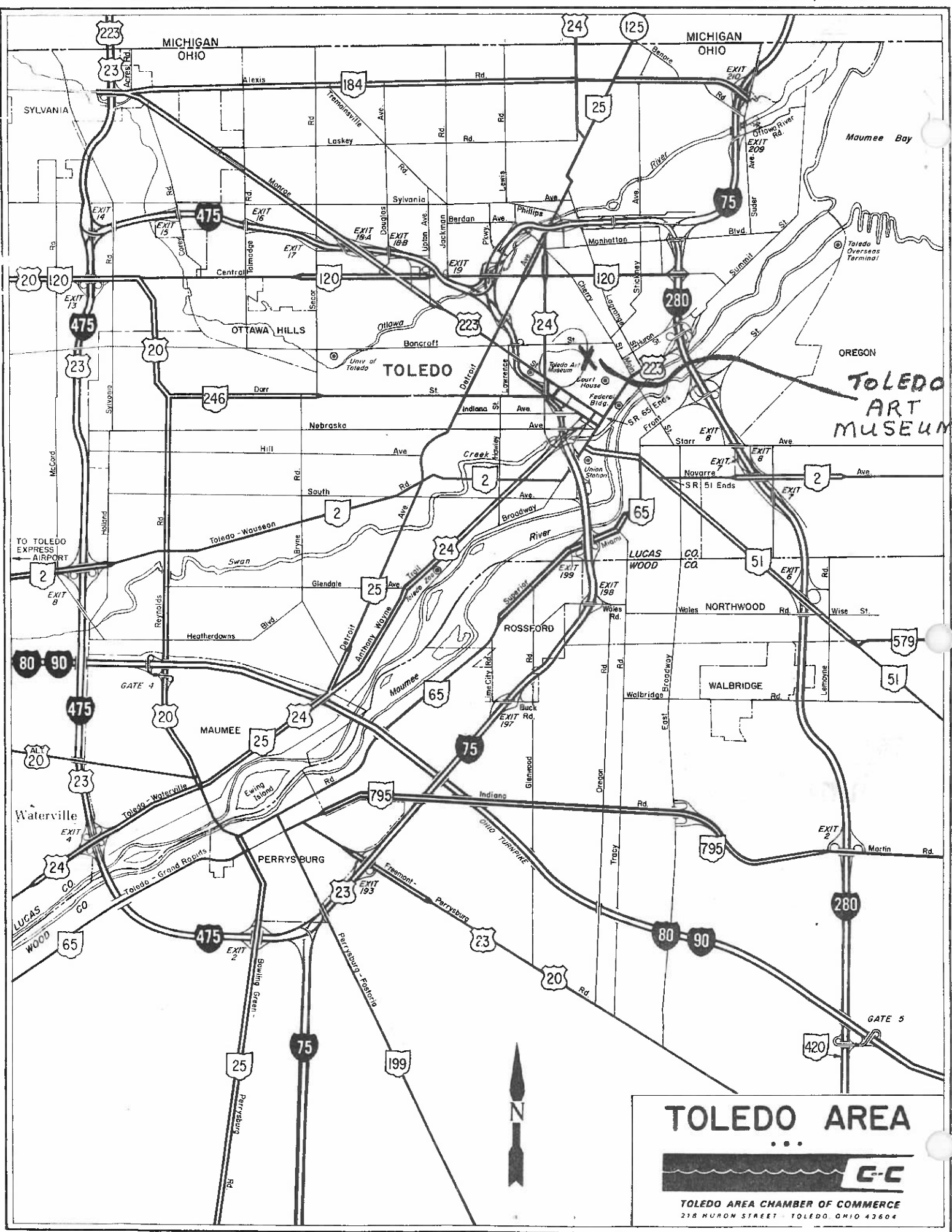
